### Program Guidelines

- É Rebates are available to residential Acton Water District (AWD) account holders. Applicant must be the owner of the property listed on the rebate application.
- É **The rebate offer is on a first-come, first-serve basis and is effective between January 1, 2010 and June 1, 2010 or until funding is exhausted, whichever happens first. All applications must be received by AWD by June 15, 2010.**
- É The rebate is \$75 per toilet and will appear as a credit on your water bill. A maximum of one toilet can be rebated.
- É Old toilets cannot be reused.
- É New construction projects do not qualify for rebates.
- É Applicant agrees and understands that the program may be discontinued and/or the rebate dollar amounts may be changed by the Acton Water Commissioners or by the exhaustion of program funding, without further notification to customers possessing outstanding applications.
- É Applicant is responsible for verifying that the new toilet is an **EPA WaterSense labeled high-efficiency toilet**. The list of eligible toilets can be accessed via the District's website at [www.actonwater.com](http://www.actonwater.com)
- É **Make sure you purchase the exact make and model # indicated on the list.**
- É An unaltered dated sales receipt, listing the make and model numbers, **MUST** accompany this application and be submitted by June 15, 2010.
- É In order to be eligible to participate in the rebate program, applicants must have an account in good standing with the AWD and agree that the AWD or its representative has the right to inspect the installation of the fixture before or after the rebate credit is applied to the applicant's water bill.
- É Applicant understands that the Acton Water District may withhold rebate until any or all of the above listed conditions are met.

Applicant agrees and understands that the Acton Water District does not guarantee that the installation of a high efficiency toilet will result in water savings, as site-specific water consumption varies. The Acton Water District does not warrant, endorse, or assume liability for the quality, performance, or safety of the contractor and/or retailer or wholesaler, or performance of any appliance or fixture. Applicant agrees to hold harmless the Acton Water District, its commissioners and employees against loss, damage, expense and liability resulting from the loss, destruction or damage to property arising out of or in any way connected with the installation of a toilet. I agree that the AWD or its representative has the right to inspect the installation of the fixture before or after the rebate credit is applied to the applicant's water bill.
