FY 22 Budget

FY 22 Warrant

Article 14 is a recent addition, requesting \$250K from the Grace Fund as a place holder to place the Assabet 3 well into service at the South Acton Water Treatment Plant. The low PFAS concentration in that well will help with the mitigation strategy in South Acton, blending with the current sources in use. Final numbers will be ready prior to the Annual Meeting.
